

## COMPLIANCE TO REACH REGULATION

April 18, 2024

### LEGAL REQUIREMENTS

The Regulation (EC) No. 1907/2006 of the European Parliament and Council of 18 December 2006 (REACH Regulation), the Regulation (EU) No. 453/2010 of the Commission of 20 May 2010 for the amendment of Regulation (EC) No. 1907/2006 and the Regulation (EU) 2015/830 of the Commission of 28 May 2015 for the amendment of Regulation (EC) No. 1907/2006 govern the registration, assessment, approval and restriction of chemical substances for better protection of humans and the environment against risks. The Regulation (EC) No. 1272/2008 of the European Parliament and Council of 16 December 2008 (CLP Regulation) governs the categorization, labelling and packaging of substances and mixtures.

### CONFIRMATION

Teesing hereby confirms that all the products and preparations within the meaning of the REACH Regulation which are supplied by Teesing:

- Only contain substances which are either not subject to registration, or which have already been registered with the European Chemicals Agency ECHA;
- Do not contain any of the 73 substances for which restrictions have been imposed according to Annex XVII of the REACH Regulation
- Do not contain any substances which are included in the 59 substances which are subject to approval according to Annex XIV of the REACH Regulation
- Do not contain any substances which are on the list of candidates by the European Chemicals Agency (ECHA) of 13.03.2024 with 240 substances of very high concern (SVHC).
- All brass articles listed in the catalog under the productgroup 'Serto Compression Fittings' which are subject to registration within the meaning of the REACH Regulations are registered in the ECHA SCIP database.

### INFORMATION OBLIGATION UNDERARTICLE 33

As a supplier of a product, Teesing has the obligation under Article 33 (1) of the REACH Regulation to inform customers if the products supplied contain one or more substances on the "SVHC candidate list" in a concentration of more than 0.1 mass % (w/w) per product. If this is the case, corresponding information will be published on the Teesing homepage at [www.teesing.com](http://www.teesing.com).

Note on lead (Pb), CAS no. 7439-92-1

In June 2018 lead (Pb) was added to the SVHC list. This means that all exceptions concerning lead (Pb) based on the RoHS Directive 2011/65/EU Annex III and IV according to Article 33, REACH, will be subject to information. Teesing products may contain lead (Pb) in a concentration of more than 0.1 mass % (w/w) per product.

According to Annex III of the RoHS Directive, exceptions are granted from the restrictions defined in Article 4 and Annex II. Exception 6c provides for a possible mass fraction of up to 4% lead for copper alloys. Teesing components made of brass have a maximum lead content of 2.2 % and are therefore compliant with the RoHS directive. Furthermore, no substances are released from our products under normal and foreseeable conditions of use.


